- C. Discuss/Approve Proclamation of April as Fair Housing Month. Middle Rio Grande Conrad Longoria. Motion by Zac Kerbow, Seconded by Vicente Ramirez
- D. Discuss the possible purchase of two lots next to Transfer Station. The gentlemen came by the office to offer the lots and mentioned the measure will not be exact. Due to sells from other locations being just measured as individual owners. Mayor asked in reference of the survey. Zac Kerbow mentioned the cost of Survey would be about \$1500. They don't have the funds to send them to the attorney every time it has been applied for. After more deliberation and explanation from Betty Schnack, A motion was on the table by Zac Kerbow. Vicenta Ramirez asked if the ECEDC has records to show the accepted Applications for the paper work. We have to show things are done right. We have made mistakes in the past. And we have to account for all we do. She has advised the City as the City Attorney and we will follow her advice. Betty Schnack Advised this has gone by for years and we don't feel She understands All the laws about the ECEDC. Questions were answered as good as possible. Mayor Gonzales asked "Can we table to the main meeting to clarify all the questions on the table. " Motion still on the table by Zac Kerbow stand as is. Motion dies. Vicenta made Motion to table the item for more information. Second by Paula Gallegos. Three in favor Zac Kerbow apposed.
