4. PUBLIC FORUM: Timothy Rios here to participate in the community. Mr. Rios looking to find ways to fix the City Park. He is interested in getting grants and the community's help to purchase items for the park usage. Vicenta Ramirez let him know there were different grants he could apply for with the state and other organizations. Some will help with 50 percent and others are also available. Motion by Vicenta Ramirez to close account. Zac Kerbow questioned the maturity date as it was wrong on the agenda then it was not valid at this time. - E. Discuss/Approve Appointment of Labor Standards Officer Conrad Longoria for Contract # 7215421. Motion to appoint Canrad Longoria as Officer made by Vicenta Ramirez, Seconded by Paula Gallegos, Zac Kerbow abstained, Christina Reyes in favor.
- F. Discuss/ Score/Approve the Hiring from Applications for Professional Engineering Services for TxCDBG Contract (TDA) for Water Systems Improvements Award # 7215421. Two contract were received by due date. Council looked over the applications. Scored and completed forms needed for program and Motion to Approve Roslin Group Inc. for services on the Approved Award # 72151421. Motion by Zac Kerbow to hire Roslin Group Vicenta Ramirez Seconded all in favor.
- G. Discuss/Approve the purchase of two lots next to Transfer Station. Discussion on lots in question needs more information. Vicenta Ramirez made a Motion to Table until Survey, Actual cost and exact footage is done and council has time to verify the information. Second by Paula Gallegos all in favor. City council is interested in the purchase of these two lots.
