# CITY OF ROCKSPRINGS, TEXAS CITY COUNCIL REGULAR MEETING MINUTES June 11, 2018

#### 1. CALL TO ORDER

Two residents representing Hillbilly Spirits 2 (Rocksprings Liquor Store) were on hand to answer any question or concerns from Council regarding the Priority 1 Grant request for \$10,000. There were no additional issues raised by those in attendance for the public forum.
